We therefore, request you to treat this letter as our resignation from the position of Statutory Auditors of the Company.

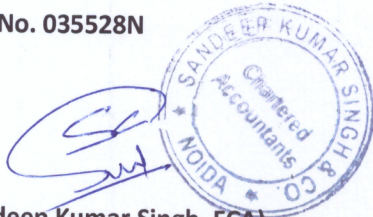
