AMAZON ANNOUNCED ON Wednesday that effectively all of the electricity its operations used last year came from sources that did not produce greenhouse gas emissions. But some experts have criticised the method the company uses to make that determination as

being too lenient. In its announcement, Amazon said it had reached its goal of 100% clean energy seven years ahead of schedule. The company said it invested billions of dollars in more than 500 solar and wind projects to achieve its target. The energy generated by those projects is equivalent to electricity consumed by the company's data centers, corporate buildings, grocery stores and fulfillment centers in 27 countries.

But because the solar and wind farms do not all directly power Amazon's operations most of that energy is sent to electricity grids that serve many businesses and homes — some
