


**To the Board of Directors of Trade wings Limited**

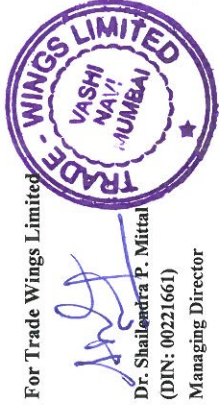
