In order to conduct business with GNO, suppliers are required to adhere to the GNO's Supplier Charter. All major vendors are assessed through Sustainable Procurement audits. Moreover, the company receives 34% of its total energy consumption for its operations from green power, ensuring a sustainable energy source.

3. Describe the processes in place to safely reclaim your products for reusing, recycling and disposing at the end of life, for (a) Plastics (including packaging) (b) E-waste (c) Hazardous waste and (d) other waste:

The production residues undergo segregation, classification, and recycling into the production process, while the hazardous wastes are disposed of in accordance with the hazardous waste management rules by authorized vendors and authorized Treatment Storage Disposal Facilities ("TSDF"). The Company has obtained Extended Producer's Responsibility ("EPR") registration and ensuring its proper recycling. Hazardous waste is incinerated or sent to authorized recyclers depending on its nature, with products like paint, oil or varnish - soaked cotton, oil - soaked sawdust, and oil filters being incinerated, while batteries such as pencil cell and while lead - acid batteries and used oil are recycled. Waste materials are appropriately labelled and disposed of in landfills/incinerated.
