Pursuant to Regulation 30 read with Clause no. 20 of Para A of Part A of Schedule III of the Listing Regulations read with SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 (“**SEBI Circular**”), this is to inform that the Company is in receipt of judgment dated July 05, 2024 passed by the High Court at Delhi where it has ordered granting an ad-interim injunction and anti-enforcement protection to the Petitioner (Honasa Consumer Limited) restraining the Respondent (RSM General Trading LLC) to execute the Decree against the Petitioner within the territorial jurisdiction of courts at Delhi, or elsewhere (“**Order**”).

The petition sought for an ad-interim injunction and anti-enforcement of the judgement dated May 16, 2024 passed by the Court of full Commercial Jurisdiction, Dubai (“Court of First Instance”) against Honasa for compensation of AED 25,071,991/- (“Decree”) as damages to RSM.</p> <p>The High Court at New Delhi passed an order granting an ad-interim injunction and anti-enforcement protection to Honasa restraining the Respondent to execute the Decree against Honasa within the territorial jurisdiction of courts at Delhi, or elsewhere. (“Order”).</p>
