Subject: Resignation as Statutory Auditor of the Company

Dear Board Members,

We refer to our appointment as the Statutory Auditors of M/s. Magellanic Cloud Limited (the 'Company') pursuant to shareholders resolution passed at the 41st Annual General Meeting held on August 10, 2022.

Further, we refer to our letter dated July 29, 2024 (and our earlier discussion) requesting an increase in the Audit fees as compared to the existing remuneration. The reason for an increase in remuneration is requested as there is a significant increase in the Company's business along with complexities involved, leading to increase in efforts and workload as compared to the earlier levels. Further, substantial component having more than 70% revenue share outside India is audited by a different auditor resulting in duplication of efforts at group level and correspondingly, increase in audit fees.

Despite these factors, our request for a reasonable fee increase based on the efforts involved has not been accepted by the management. We understand that our request and the Company's response have been suitably discussed with the Audit Committee.

Under these circumstances, and after reassessing our ability to continue as auditors in accordance with the Standards on Auditing and the Standards on Quality Control issued by the Institute of Chartered Accountants of India, we hereby convey our decision to resign as the Statutory Auditors of the Company.

Our resignation will take effect after the conclusion of the forthcoming Board Meeting scheduled to be held on today i.e. August 14, 2024. We assure you that we will provide all necessary assistance and information required by the Company, including information needed in accordance with the circular issued by the Securities and Exchange Board of India (SEBI) bearing number CIR/CFD/CMD1/114/2019 dated October 18, 2019.
