EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

As required by Section 102 of the Companies Act, 2013 (the "Act"), and the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 (the "SEBI ICDR Regulations") the following Explanatory Statement sets out all material facts relating to the business items mentioned in the Notice:

ITEM NO. 1

With reference to our company's Extraordinary General Meeting of shareholders held on Thursday, 18th April, 2024; the company had received the requisite approval of the shareholders for raising of funds by way of issue of upto 65,57,377 8% unsecured, unrated, listed Optionally Convertible Debenture (OCDs) in one or more tranches of the Company at an issue price of Rs. 30.50/- each ("Issue Price/Conversion Price") for an aggregate amount of upto Rs. 20,00,00,000/- (Rupees Twenty Crore Only) to **Quantum Quasar Capital** ("Proposed Allottee"), for cash consideration, by way of a preferential issue through private placement offer on such terms and conditions as were detailed in the EGM notice dated 19th March 2024.

Further, the company had detailed in its EGM notice dated 19th March, 2024; that the objects of the above issue was to meet the long-term fund requirement; strategic business needs of the company and to support the future growth of the business and to further augment the long-term financial resources of the Company and such other purposes, as may be determined by the Board of Directors of the Company ("Board") from time to time.

Moreover, the company had received the requisite "in principle approval for preferential issue" from the stock exchange i.e. BSE Limited vide their Approval letter dated 04th June, 2024.

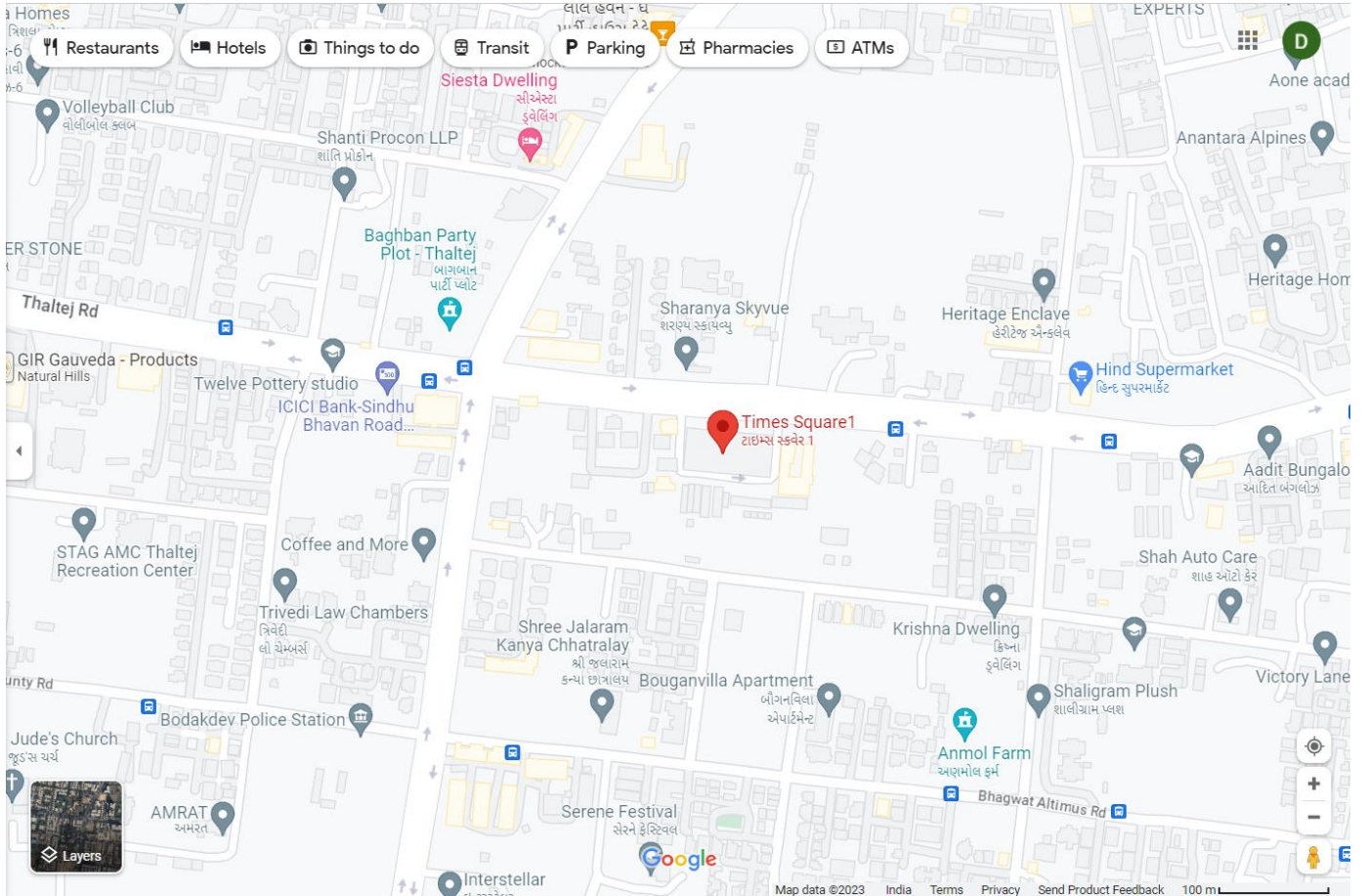
