Subject: Outcome of the Board Meeting dated 10th July, 2024 - Allotment of Equity Shares under the provisions of Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 and applicable provisions of Companies Act 2013 and the rules made thereunder, each as amended (the "Preferential Issue")

Reference: Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the 'Listing Regulations') and pursuant to the approval of the Board of Directors of Jet Infraventure Limited (the "Company") at its meeting held on May 29, 2024 and the approval of the members of the Company at their Extra Ordinary General Meeting held on June 25, 2024 and in accordance with the In-principle approval granted by BSE Ltd ("BSE") vide its letter dated June 25, 2024, the Board of Directors of the Company, vide its meeting held today i.e. Wednesday, July 10, 2024, has approved the allotment of 23,12,000 (Twenty Three Lakhs Twelve Thousand Only) fully paid up Equity Shares of face value Rs. 10/- (Rupees Ten Only) each ("Equity Shares") to the allottee(s) at a price of Rs. 16.25/- (Rupees Sixteen and Twenty Five Paisa Only) per Equity Share (including premium of Rs. 6.25/- each (Rupees Six and Twenty Five Paisa)) for cash on preferential basis, aggregating to cash consideration of Rs. 3,75,70,000/- (Rupees Three Crore Seventy Five Lakhs Seventy Thousand only) who have accepted the offer, as detail provided under **Annexure-I.** 

The allotment has been undertaken in accordance with the provisions of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 and other applicable rules/regulations /guidelines, if any, prescribed by any other regulatory or statutory authorities.

The Equity Shares will be listed on BSE Limited.

The new Equity Shares as allotted above shall rank pari passu, in all respects with existing Equity Shares of the Company save and except lock-in obligations as per applicable laws. The Company has received in-principle approval from BSE Limited ("Stock Exchange"), for the issue of aforesaid Equity Shares on Preferential basis, on June 25, 2024. The application for listing and trading approval to the Stock Exchange for the Equity Shares allotted as above will be made in the due course.



Consequent to said allotment, the issued, subscribed and paid-up equity share capital of the Company would increase from Rs. 4,19,20,000/- (Rupees Four Crore Nineteen Lakh Twenty Thousand) to Rs. 6,50,40,000/- (Rupees Six Crore Fifty Lakhs Forty Thousand).

The details in respect of the Preferential Issue, as required to be disclosed under Regulation 30 of the SEBI Listing Regulations, read with the SEBI Circular No. SEBI/HO/CFD/CFD-PoD- 1/P/CIR/2023/123 on disclosure of material events/ information by listed entities, dated July 13, 2023 ("SEBI Disclosure Circular") is set out below at **Annexure – II.** 

The meeting commenced at 12:00 noon and concluded at 12:30 p.m.
