# ACB gives notice to Kejriwal, others over horse-trading claim

AS CANDIDATES, PARTIES and the city braced for the counting of votes Saturday to decide a new government and Assembly in Delhi, the Anti-Corruption Branch (ACB) showed up at the door of the ruling AAP Friday to serve notices to its leaders over claims that the rival BJP had offered bribes to AAP MLAs and others to jump ship.

The ACB issued notice to AAP convener and former chief minister Arvind Kejriwal, in addition to other senior party leaders, to join an inquiry regarding allegations that the BJP was seeking to poach sitting and potential AAP legislators to form the next government in Delhi.

On Thursday, Kejriwal and AAP Rajya Sabha MP Sanjay Singh alleged that the BJP had embarked on 'Operation Lotus' in Delhi, and was seeking to bribe as many as 16 leaders of their party, offering each ₹15 crore, to jump ship.

Responding to the allegation, Delhi BJP president Virendra Sachdeva called it a result of panic arising out of "frustration" and the AAP's acknowledgment of its "seemingly inevitable defeat". On Friday, the Delhi BJP wrote to Lieutenant Governor V K Saxena

seeking registration of a case against AAP leaders, including Kejriwal, over the party's allegation of the BJP approaching AAP MLAs with bribes.

Sanjay Singh told reporters: "They have tried to break our candidates, we are going to complain, we have already released a phone number from which one candidate got a call. The ACB should act, not create drama. I dare the ACB to take action against these BJP leaders."

An ACB team reached Kejriwal's residence on Ferozeshah Road but was not allowed inside since it "did not have any

official warrant" or documentation related to the proposed enquiry, according to the AAP. Following this, the anti-graft body issued a notice to Kejriwal as well as AAP minister Mukesh Ahlawat, who had made a similar allegation, asking them to make themselves available to provide information regarding the allegations.

"Whether the tweet posted at the following URL of X (formerly Twitter), has been posted by you or otherwise?...Details of the 16 candidates for MLA of AAP who received phone calls regarding the offer of a bribe," the ACB stated in its notice.

# DOGE staffer quits over racist posts

A KEY STAFF member of US President Donald Trump's newly created Department of Government Efficiency or DOGE, headed by Elon Musk, resigned on Thursday owing to racial social media posts, including against India, *The Wall Street Journal* (WSJ) has reported.

Marko Elez, 25, deployed by DOGE to scrutinise federal spending, resigned after WSJ asked the White House about his connection to the deleted social media account, said the report.

"Just for the record, I was racist before it was cool," the account posted in July, according to the WSJ's review of archived posts.

"You could not pay me to marry outside of my ethnicity," the account wrote on X in September, according to the report. "Normalise Indian hate," the account wrote the same month, in reference to a post noting the prevalence of people from India in Silicon Valley.

Later, White House spokesperson Karoline Leavitt said that Elez had resigned from his role. In recent days, Elez had also emerged at the centre of a legal battle over access to sensitive taxpayer information and systems the Treasury Department uses to process trillions of dollars in payments annually.

On the day Elez quit, a US District Court judge also ruled that he could continue to access the department's pay-

ment systems, but limited his ability to share the data.

Elez majored in computer science from Rutgers University. He co-founded Unimetrics.io, which aimed to connect high-schoolers with mentors who could help burnish their college applications.

Elez worked for Musk at SpaceX, including on its Starlink satellites, and X, where he focused on artificial intelligence, according to archives of his personal website quoted by WSJ.

Musk, who also owns Tesla, besides X and SpaceX, had recently weighed in to favouring the hiring of H-1B visa-holders and said he "will go to war" on the issue and asked right-wingers to "take a big step back". The H-1B programme allows businesses in the US to employ skilled foreign nationals.

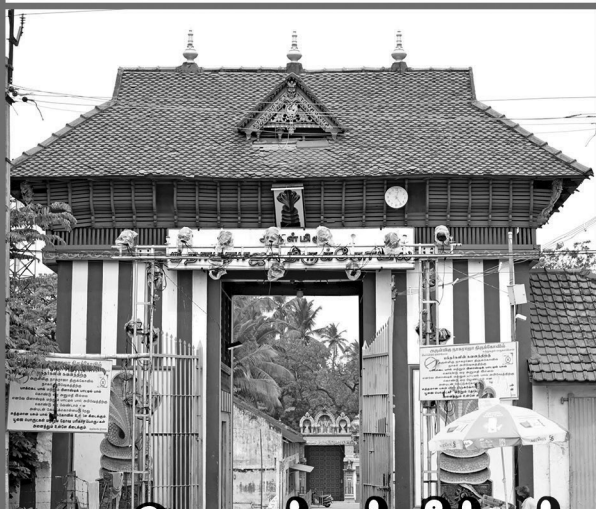
