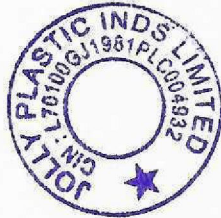

The content of order has been reproduced below for the stakeholders:

"In view of the aforesaid, we are of the opinion that in view of the inordinate delay in the issuance of show cause notice the impugned order cannot be sustained and is quashed. The appeal is allowed. All the misc. applications are accordingly disposed of."

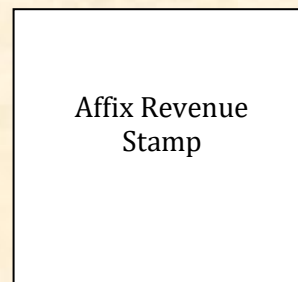

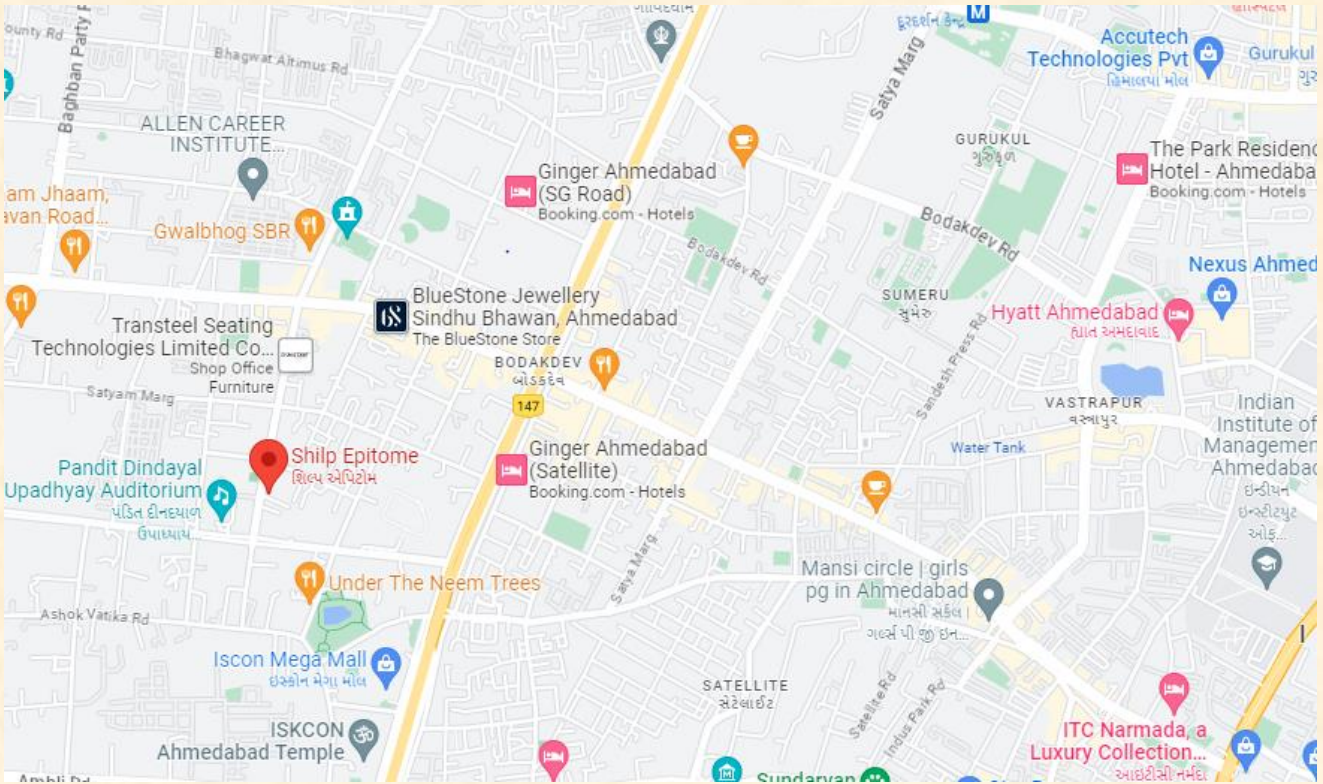
