cast their vote through National Securities Depositary Limited. Members who were present at the AGM and who have not casted their vote electronically were provided with an opportunity to cast their vote through poll. It was further informed that there would not be any voting by show of hands.

The Chairman informed that Ms. Rashida Adenwala from R&A Associates, Practicing Company Secretaries was the Scrutinizer appointed by the Board to scrutinize the votes in a fair and transparent manner.

### Item no.4

Appointment of Mr. Adarsh Gupta (DIN: 00526687) as an Independent Director (Non-Executive) of the company. (Special Resolution)

To Approve the Related Party Transaction for Sale of Land to M/s. Rishikesh Yarns (Ordinary Resolution)



### Item no.6

Approval of Related Party Transactions. (Ordinary Resolution)

#### Item no.7

Alteration of the Object Clause of the Memorandum of Association of the Company. (Special Resolution)

#### Item no.8

To Approve granting authorization to board of directors to advance any loan, give any guarantee or to provide any security to all such person specified under section 185 of the companies act, 2013 upto an aggregate limit of Rs.3,00,00,000 (Rupees Three Crore Only). (Special Resolution)
