It may be noted that Mr. Nagnur shall continue to be the Bank's Chief Technology Officer and will also be responsible for Operations of the Bank as also the Group Technology Architecture and Cyber Security; and
- 5. Appointment of Mr. Paul Parambi, currently the Chief Risk Officer of the Bank, as the **Group Chief Risk Officer** of the Bank, with effect from March 1, 2024.
