names appeared on the Register of Members / List of beneficiaries as on 22nd March, 2019 and published the advertisement pursuant to Rule 22(3) of the Companies (Management and Administration) Rules, 2014 on 3rd April, 2019, the voting commenced on 2nd April, 2019 (at 10.00 A.M.) and ended on 1st May, 2019 (5.00 P.M.) for physical ballots and as well as for e-voting. The e-voting facility was provided by National Securities Depository Limited (NSDL).

- The Postal Ballot Forms were kept under my safe custody before commencing the scrutiny of such Postal Ballot Forms.
- 4.
