- 1. | Mr. N. L. Bhatia, a Practising Company Secretary in practice, was appointed as the Scrutinizer by the Hon'ble National Company Law Tribunal ("NCLT") by its order dated April 22, 2019:
 - To scrutinize the Postal Ballot and e-voting and voting through electronic means at the meeting for the item to be transacted at the NCLT Convened Meeting held to be held on 3rd June, 2019 under the provisions of Section 108 and 110 of the Companies Act, 2013 (the Act) read with Rule 20 and Rule 22 of the Companies (Management and Administration) Rules, 2014 as amended (Rules);
 - 2. The management of the Company is responsible for ensuring compliance with the requirements of the Act and the Rules relating to voting through Postal Ballot, e-voting and voting through electronic means at the meeting on the resolution contained in the Notice of the Meeting.

- 3. My responsibility as a scrutinizer for the voting process, was restricted to scrutinize the Postal Ballot, e-voting process and voting through electronic means at the meeting in a fair and transparent manner and to prepare a consolidated Scrutinizer's report of the votes cast "in favour" or "against" the resolution stated in the Notice, based on postal ballot and the reports generated from the e-voting system provided by NSDL and voting through electronic means and/or ballot at the meeting.
- 4. The Company has appointed M/s. National Securities Depository Ltd ("NSDL") to provide e-voting facilities to the Equity Shareholders of the Company from 09:00 A.M. on 04th May, 2019 to 5:00 P.M. on 02nd June, 2019 .The voting by Postal Ballot and E-voting commenced on Saturday, the 04th May, 2019 at 9.00 a.m. and ended on Sunday, the 02nd June, 2019 at 5.00 P.M and the voting by electronic means was carried out at the meeting.
- 5. In terms of the Notice dated 25th day of April 2019, for NCLT Convened Meeting, the shareholders who have already voted through postal ballot or Evoting were not entitled to vote at the NCLT Convened Meeting. Accordingly, shareholders who have exercised their right to vote either through postal ballot or E-Voting and also subsequently voted through electronic means at the NCLT convened meeting, then such voting through electronic means was not considered and counted.
- 6. The percentage of votes in favour and against is calculated on the total number of valid votes cast.
- 7. To ascertain the number of shareholders, shareholders holding multiple Member IDs were treated as one Shareholder.
- 8. Based on the report on results of voting by Postal Ballot and e-voting and voting by electronic means and/ or ballot at the meeting as required under SEBI Circulars bearing Nos. CFD/DIL3/CIR/2017/21 dated 10th March 2017 issued by the Securities and Exchange Board of India the resolution is passed with the requisite majority.
