This is further to our letter dated 15 November 2023, vide which we had informed about RBI order directing the Company to stop sanction and disbursement of loans under its two lending products namely, 'eCOM' and 'Insta EMI Card'.

We would like to further inform that the Company has temporarily suspended issuance of Existing Member Identification cards ('EMI cards') to new customers till such time that the deficiencies observed by RBI are rectified to their satisfaction. The Company continues to offer financing to new and existing customers at dealer stores in the normal course of business.

We further wish to inform that the above action, together with the actions communicated in this regard on 15 November 2023, will not have a material financial impact on the Company.

The Company is in the process of implementing requisite actions to make good the deficiencies at the earliest, and will continue to engage with RBI to ensure compliance on all parameters.
