**19<sup>th</sup> Annual General Meeting** of the members of Compuage Infocom Limited (CIN: L999999MH1999PLC135914) held at Victoria Memorial School for Blind, Tardeo Road, Opp. Film Centre, Next to Girnar Tower, Mumbai-400034 on Friday, 28<sup>th</sup> September, 2018 at 10:00 a.m.

#### Sub: Passing of Resolution(s) through remote e-voting and poll pursuant to Section 108 and 109 of the Companies Act, 2013 read with Rule 20 and 21 of the Companies (Management and Administration) Rules, 2014 as amended.

The Board of Directors of **Compuage Infocom Limited** (hereinafter referred to as the "Company") at its meeting held on 10<sup>th</sup> August, 2018 has appointed me as the Scrutinizer for the Remote E-Voting as well as to scrutinize the voting through poll papers received from the members at the venue of the Annual General Meeting pursuant to Section 108 and 109 of the Companies Act, 2013 read with Rule 20 and 21 of the Companies (Management and Administration) Rules, 2014 as amended. I say, I am familiar and well versed with the concept of electronic voting system as prescribed under the said Rules.

#### Report on Scrutiny:

- The Company has appointed National Securities Depository Limited ('NSDL') as the Service Provider for the purpose of extending the facility of remote e-voting to the Members of theCompany.
- Link Intime India Private Limited is the Registrar and Share Transfer Agent of the Company.
- The Service Provider had provided an Electronic Voting system for Remote E-Voting by members on all items of the business (both Ordinary and Special business) sought to be transacted in the 19<sup>th</sup> Annual General Meeting of the company, which was held on Friday, 28<sup>th</sup> September, 2018.



- The Service Provider had set up electronic voting facility on their website, https://www.evoting.nsdl.com/. The Company has uploaded all the items of the business to be transacted at the AGM on the website of the Company and also it's Service Provider to facilitate their members to cast their vote through remote e- voting.
- The cut-off date for determining members for the dispatch of the Notice for the Annual General Meeting was 17<sup>th</sup> August, 2018 (Physical & Email) and as on that date, there were 7,919 members of the Company. The Company had sent the notices of the Annual General Meeting by E-mail to 6,041 members out of whom transmission of E-mails to 480 Shareholders had failed. In respect of 1,878 members, E-mail IDs were not available and hence the notices were sent by Courier and Speed Post.
- The Company completed the dispatch of the notice of the Annual General Meeting along with Annual Report in physical form and through E-mail on 28<sup>th</sup> August, 2018.
- The Notices sent (both through E-mail and physical form) contained the detailed procedure to be followed by the Members who were desirous of casting their votes electronically as provided in the Rule 20 of the Companies (Management and Administration) Rules, 2014 as amended from time to time.
- The Cut-off date for the purposes of identifying the Members who will be entitled to vote on the resolutions placed for approval of the Members was 21<sup>st</sup>September, 2018.
- As prescribed in the aforesaid Rules, the Remote E-Voting facility was kept open for Three days from Tuesday, 25<sup>th</sup> September, 2018 at 09:00 a.m. (IST) to Thursday, 27<sup>th</sup> September, 2018 till 5:00 p.m. (IST).
- As prescribed in clause (v) of sub rule 4 of the Rule 20, the Company also released anadvertisement, which was published more than 21 days before the date of the AGM in English in 'Business Standard' newspaper dated 29<sup>th</sup> August, 2018 having country-wide circulation and in Maharashtra in 'Mumbai Lakshadweep' newspaper dated 29<sup>th</sup> August, 2018. The notice published in the newspaper carried the required information as specified in Sub Rule 4 (v) (a) to (h) of the said Rule 20.
- At the venue of the 19<sup>th</sup> Annual General Meeting of the Company held on 28<sup>th</sup> September, 2018 the facility to vote through poll was made available to facilitate those members present in the meeting but could not participate in the Remote E- Voting to record their votes.



- On 28<sup>th</sup> September, 2018 after counting of the votes conducted at the venue of the AGM through poll paper, the votes cast through remote e-voting facility was duly unblocked by me as a Scrutinizer in the presence of Mr. Parbat V. Chaudhari and Mr. Daniel C. D'souza who acted as the witnesses, as prescribed in Sub Rule 4(xii) of the said Rule 20.
- After the voting at the Annual General Meeting was concluded, the locked Ballot box was subsequently opened in the presence of two persons as witnesses, as mentioned above and poll paper were diligently scrutinized. The poll papers were reconciled with the records maintained by the registrar and Transfer Agents of the Company and the authorizations and proxies lodged with the Company.
- Thereafter, 1 as a Scrutinizer, duly compiled details of remote e-voting and the facility of voting through poll papers provided at the venue of the AGM, the details of which are as follows:
