Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

With reference to the captioned subject, we wish to inform you that the Bank has, on August 29, 2024, received an order dated August 29, 2024 from the office of the Assistant Commissioner, Central Goods & Service Tax, Noida, Uttar Pradesh, levying an amount of Rs. 16,14,944/- towards Goods and Services Tax ("GST") and the interest as applicable under Section 50 of the Central Goods and Services Act, 2017 ("CGST Act") and a consequential non-discretionary penalty amounting to Rs. 1,61,494/- under Section 122 (2) (a) of the CGST Act / the Uttar Pradesh Goods and Services Tax Act, 2017 ('UPGST Act'). The above demand has arisen mainly on account of disallowance of input tax credit ('ITC') during the financial year 2019-20.

The Bank believes that it has adequate grounds to support its position in the matter and would prefer an appeal against the aforesaid order, under the applicable laws. The impact of the above order would be limited to the amount of levy payable by the Bank under the aforesaid order.

We request you to take the above on record and disseminate the same on your website.
