1. Considered and approved the un-audited financial results of the Company for the first quarter ended on **30th September, 2018**.

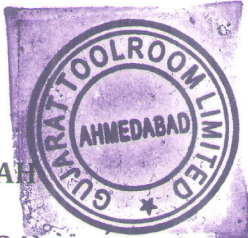

Independent Auditor's Review Report on Review of Interim Financial Results

1. 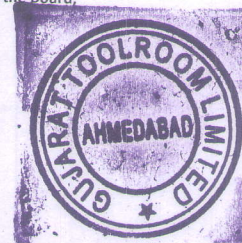
