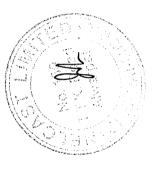

## I submit my report as under:

- 1. The shareholders holding shares as on the "cut-off" date i.e., 15<sup>th</sup> February 2019 were entitled to vote on the proposed resolutions (Item Nos. 1 and 2).
- 2. The e-voting commenced on  $22^{nd}$  February 2019 (9.00 a.m.) and ended on  $23^{rd}$  March 2019 (5.00 p.m.).
- 3. In respect of e-voting the details containing, inter-alia, list of equity shareholders, who voted "For" and "Against" were downloaded from the e-voting website of NSDL (https://www.evoting.nsdl.com).
- All Postal Ballot forms received up to the close of working hours on 23.03.2019 the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
- 114 Physical Postal Ballot Forms were received and 96 shareholders casted their votes on the e-voting platform.
- 6. The Register, all other papers and relevant records relating to electronic voting shall remain in my safe custody until Chairman considers, approves and signs the Minutes of the aforesaid Postal Ballot and the same will be handed over to the Company Secretary for safe custody.

- 7. Particulars of all the Postal Ballot forms received from the members have been entered in a register separately maintained for the purpose.

- 11. While all the electronic ballots were treated as valid, 8 physical ballots were treated as invalid for various reasons as mentioned in the Instructions to the Postal Ballot Form.
- 12. In cases where the shareholders who casted their votes both through Postal Ballot as well as through e-voting, then votes casted through e-voting has been considered.
