Subject: Intimation of third grant of Stock Options pursuant to Bajaj Auto Employee Stock Option Scheme 2019 ('BAL-ESOS 2019')

This is to inform you that pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and subject to the provisions of SEBI (Share Based Employee Benefits) Regulations, 2014, the Compensation Committee of the Board, at its meeting held on 27 April 2022, has granted **4,47,692** stock options convertible into **4,47,692** equity shares of Rs. 10 each to the eligible employees of the Company under the BAL-ESOS 2019 at an exercise price of **Rs. 3,892.10** (being the closing market price as on 26 April 2022) per option. Each of the stock option entitles the holder to apply for one equity share of the Company of Rs. 10 face value.

The following are the main terms of the options granted:

- a) Vesting period: The options would vest not earlier than 1 year and up to 10 years from the date of aforesaid grant of options.
- b) Pricing formula: The options have been granted at the market price as defined under SEBI (Share Based Employee Benefits) Regulations, 2014.
- c) Exercise period: The Stock Options are excisable within 5 years from the respective date of vesting.
