We have completed all the audit assignments of the company for the year ended on March 31, 2023.


We request you to accept our resignation and please inform us your decision on the above resignation.

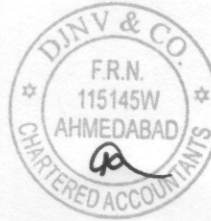
