Dear Sir,

This is with reference to the query raised by your good office vide your email dated 24 November 2020 in relation to disclosure dated 9 October 2020 made by us pursuant to Regulation 31 of the SEBI SAST Regulations, 2011 ("NDU Disclosure") and with directions to submit a revised disclosure.

In this regard, we hereby submit the following facts for your kind consideration:

- A non-disposal undertaking ("NDU") was created by Zuari Global Limited on 1,25,00,000 (One Crore twenty five lakh) shares of Chambal Fertilisers and Chemicals Limited ("CFCL") held by it, in accordance with the terms and conditions of the debenture trust deed dated 6 October 2020 executed between Zuari Global Limited and Vistra ITCL (India) Limited ("Debenture Trust Deed") in connection with issuance of non convertible debentures aggregating to Rs. 170 Crores ("Debentures") to Asia-Pacific Private Credit Opportunities 1 Singapore Pte Limited ("NCD Subscriber").
- At the time of making the NDU Disclosure, out of 1,25,00,000 shares which were required to be subject to the NDU, 85,47,332 shares of CFCL held by Zuari Global Limited were free from any pledge and the remaining 39,52,668 shares of CFCL held by Zuari Global Limited were pledged with Axis Finance Ltd ("Axis Shares"). Further, as on the date of the NDU Disclosure, out of total shareholding of 5,90,15,360 held by Zuari Global Ltd, 5,04,68,028 shares were pledged.
- The terms of the Debenture Trust Deed contemplated that the Debenture proceeds among others, will also be utilized to repay the amounts outstanding and payable by Zuari Global Limited to Axis Finance Ltd ("Axis Loan") which were secured by a pledge over the Axis Shares.
- In light of the above, the NDU Disclosure which was made on 9th October 2020 was made subject to the provisions of the Debenture Trust Deed and accordingly the encumbrance was created over the Unencumbered CFCL Shares and the Axis Shares.
