1.7	Impact of the COVID-19 pandemic on the business	The world has been affected with an unprecedented epidemic COVID -19 which has adversely affected the lives and livelihood of the people of the virtually all countries.  Simplex Castings Limited being a reputed manufacturing company known for it's designing ,engineering and customised product manufacturing for 70% of PSU's and 30% for Private customers forced to remained shut down from 24th March, 2020 and partially resumed w.e.f 23th April,2020.  Nation wide lock down have been extended thrice and fourth phase is completed on 31st May, 2020. The outbreak (COVID-19) totally ceased anykind of business globally and the uncertainity around how long this will last therefore as stated rightly by our Respected RBI Governor India by all indications, the economy is in dire straits, GDP growth to hit "zero" in FY 21. Lockdown has led to near halt in manufacturing unit and left many skilled migrants labours in jeopardy.  In the present situation, it is difficult to ascertain the overall
		impact of the outbreak. The pandemic is significantly impacting business operation of the Company, by way of supply chain disruption, unavailability of personnel, closure / lock down of operating facilities etc. The lockdown, lots of restrictions and unexpected variables shall adversely result in to the operations and future growth plans of the Company.
2.	Ability to maintain operations including the factories/units/office spaces functioning and closed down;	After getting necessary permissions from the Government and the concerned local authorities and ensuring compliances related to Covid-19 guidelines, the Company has begun plant operations in phased manner from April 23, 2020. Currently, our plants located at Bhilai (Chhattisgarh) and Tedesara (Chhattisgarh), are operating with only 40% manpower and other resources. The Registered and Corporate office of the Company were operating on a Work-

4.	Steps taken to ensure smooth functioning of operations	The Company is following all relevant Government directives and guidelines regarding health and safety of the workforce on their all the premices.
		The Company is facing Challenges to maintain the Stock Level. Efforts are being made for smooth despatches of the finished goods. Normalization of external logistics is awaited. The Company has applied for all the policies which has been annoused by Government of India, But no relaxation is being provided by Authorities.
5	Estimation of the future impact of CoVID-19 on its operations	The temporary suspension of manufacturing and the continuing reduced levels of operation are likely to have significant financial impact, the extent of which is not quantifiable, as the rate of resumption and ramping up of operations is yet difficult to predict. An attempt to formulate estimates will become speculative at this point. The Company is making every effort to mitigate this. The Company is relooking on the business strategy.

c.	Liquidity position	The Company don't have comfortable Liquidity position due to inadequate banking limits and stringent banking norms.




