NCLT Okays Hinduja Unit's Rel Cap Acquisition Plan

Mumbai: The bankruptcy court in Mumbai on Tuesday allowed an application filed by the administrator of Reliance Capital to approve the Anil Ambani-promoted company's acquisition by Hinduja group-owned IndusInd International Holdings through the insolvency resolution process.

The National Company Law Tribunal (NCLT), led by judicial member Virendra Singh Bisht and technical member Prabhakar Kumar, approved the plan.

IndusInd International became the preferred bidder through a second round of bidding. Torrent Investments, which was the highest bidder in the first round, has challenged the validity of the second challenge in the Supreme Court. The verdict is pending.

"However, these authorities (such as RBI, SEBI, Income Tax department and IRAD) shall not withhold its approval for the reasons of insolvency of corporate debtor or part/non-payment of their dues under the plan," said the order.

"The resolution applicant shall be permitted to continue to operate its business as a going concern without disruption for the benefit of the resolution applicant for a period of 12 months provided such resolution applicant has taken up appropriate steps with the concerned authority in relation to renewal thereof."

The company had concluded e-voting on resolution for approval of the resolution plan on June 29 last year.

"To monitor the implementation of the revival plan, a monitoring committee will be formed as per the plan so

law firm Cue Legal said this was among some of the big insolvency resolutions of financial institutions after that of Dewan Housing Finance and Kolkata-based twin Srei group companies.

Torrent Investments has challenged the view taken by the NCLAT about regulation 39 (1A) of the Insolvency and Bankruptcy Board of India that it does not restrict the rights of lenders to continue negotiation on financials and the decision to mount a second challenge.

that there is no vacuum between the period of approval and the complete satisfaction of the terms of the plan," said Ashish Pyasi, partner, Aendri Legal.

Veteran lawyer Shardul Shroff had approached the Supreme Court on behalf of Torrent Investments in October last year with a plea to speed up the hearing on the company's application to stay the second challenge mechanism in the corporate insolvency resolution process for Reliance Capital.

The bid from the Hinduja group entity given 24 hours after the auction deadline (December 21, 2022), trumped the offer made within the stipulated time by Torrent Investments. Then the lenders decided to hold a second round of auction.

The administrator has admitted ₹26,086 crore of claims from lenders as of June 8, 2023. The successful bidder had offered ₹9,661 crore, signifying 37% recovery for the lenders.
