Further, Promoters have so far pledged totally 27.28% of total share capital of the Company (comprising of 30,225,000 equity shares) on various dates which includes pledge created on 4,00,000 equity shares on 26th August, 2021.
- 6. The Promoters intends to utilise the proceeds to re-invest in Wockhardt Limited to fund its capacity expansion/ working capital requirements, subject to necessary approvals.
