<u>Subject: Resignation as Statutory Auditors of the MT Educare Limited ('the Company') from the Financial Year 2020-21: Final communication</u>

This letter is in continuation to our various communications since 14 May 2020 informing the Company of our intention to resign as statutory auditors for the upcoming Financial Year 2020-21. While we have not received a formal response to our communications till date, it is informed by the Company's management, that our proposed resignation will be placed for discussion in the meeting of the audit committee as well as in the meeting of the board of directors to be held on 25 September 2020.

As you are aware, we, MSKA & Associates, Chartered Accountants (FRN 105047W) ('the Firm') were appointed as the Statutory Auditors of the Company from Financial Year 2016-17 to 2020-21 at its 10th Annual General Meeting held on September 28, 2016.

We have completed our statutory audit in respect of the financial statements for the year ended 31 March 2020 and issued Auditor's reports related to the standalone and consolidated financial statements on 25 September 2020.

In accordance with the applicable framework laid down under SQC 1 "Quality Control for Firms that Perform Audit and Reviews of Historical Financial Information, and Other Assurance and Related Services Engagements", the Firm has laid down policies and procedures to evaluate "client/engagement continuation" on a regular basis. In accordance with the said process, the Firm has re-evaluated its "engagement reacceptance" criterion in view of the recent group wide organisational changes in key management personnel including composition of the board of directors. Moreover, the new management has expressed their intention to align with the group auditors of the parent company. Basis our annual re-evaluation and on-going discussions with the new management, our client continuance criterion for the financial year ended March 31, 2021 are not met.

We further note and as discussed with management from time to time, the level of audit fees at present are not commensurate with the level of effort undertaken to perform the statutory audit of the Company including limited reviews thereof for three quarters.



In view of the above, we express our inability to continue as statutory auditors of the Company for Financial year 2020-21 and accordingly tender our resignation, with effect from the conclusion of the Board meeting dated 25 May 2020, wherein the results of the year and quarter ended 31 March 2020 would be approved. Pursuant to SEBI circular no CIR/CFD/CMD1/114/2019 dated 18 October 2019, we have completed the year end audit for 31 March 2020.

We take this opportunity to reiterate our appreciation and gratitude to the Management of the Company for the courtesy and co-operation extended to us.
