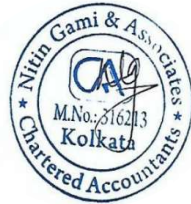
I therefore, request your good office to treat this letter as resignation from the post of Statutory Auditors of the Company with immediate effect.
