For and on behalf of the Governor of Tamil Nadu, the negotiated tender of **M/s.RPP Infra Projects Ltd**, S.F.No:454, Raghupathynaiken Palayam, Poondurai Main Road, Railway Colony Post, Erode - 638002 at **0.01% Less Estimate rates 2022-23 SOR with GST 12%** for a total value of **Rs.104,79,34,980/-** (Rupees One Hundred Four Crores Seventy Nine Lakhs Thirty Four Thousand Nine Hundred and Eighty only) (with **Base cost of Rs. 93,56,56,232/-** and **GST at 12% of Rs. 11,22,78,748/-**).

1. For the due performance of the contract, within 15 days from the date of receipt of the letter accepting your tender, you shall furnish a Security Deposit amount of 2% of awarded contract value.
2. In this regard, you have already furnished **Earnest Money Deposit for Rs.52,51,000/-** in the form of Deposit Receipt. Hence are requested to furnish a **Security Deposit of Rs.2,09,60,000/-**

(Rupees Two Crore Nine lakh and Sixty Thousand Only), for executing the agreement, covering both **EMD & FSD** valid for Construction period and Defect Liability Period before executing the agreement, in anyone of the following terms:

You should produce the consent letter of Engineers to be engaged by you for this work and copy of their qualification certificates for, **One** Engineer BE Civil Engineering Degree holder with **10 years** experience in similar works, **Three Engineers** with BE Civil Engineering Degree holder with **5 years** experience in similar works and **Six Engineers** with Diploma in Civil Engineering with **5 years** experience in similar works, for executing the agreement.
6. You should attend the office of the Superintending Engineer (H), CMDP Circle, Saidapet, Chennai-15 with all the above mentioned particulars within 15 days from the date of receipt of this letter and you should be prepared to sign the Lumpsum Agreement in the presence of the witness of known probity and wealth.
7. Execution of Contract shall conform to cl.104.04 of PS to SSRB. The written Lumpsum Agreement to be entered into between you and the Government shall be the foundation of all rights of both the parties and the contract shall not deemed to be complete until the agreement is signed by you first and then by the proper officer authorized to enter into contract on behalf of the Government of TamilNadu.
