WESTERN RAILWAY CARRIES OUT VARIOUS WORKS TO ENHANCE CONNECTIVITY WITH TUNA PORT NEAR GANDHIDHAM

Ahmedabad, Western Railway is contributing immensely towards the infrastructural development of railways in Gujarat and in the last few years, tremendous boost has been given to works related to port connectivity along with gauge conversion, electrification, doubling and other infrastructural upgrades including enhancement of passenger amenities. Western Railway has accomplished the feat of enhancing the connectivity of Tuna port with Gandhidham and remodelling of Gandhidham Yard. The work has been completed and successfully commissioned on

10th February, 2022. According to a press release issued by Shri Sumit Thakur - Chief Public Relations Officer of Western Railway, several traffic facility and safety works have been carried out such as providing interlocking between Gandhidham and Tuna Port, commissioning of shunting neck, provision of additional loop lines at Gandhidham yard, provision of Gandhidham Cabin between Gandhidham and Shirva stations on Gandhidham-Kandla Port section and interlocking at Level Crossing No. 01. These upgradations



will help in enhancing safety and will boost freight operations from Tuna Port and Kandla Port. These upgradations will provide impetus to the freight operations of Western Railway and will help in seamless movement of freight traffic for these ports.

Six Pakistani fishermen held after 11 boats seized in Harami Nala

AHMEDABAD: The Border Security Force (BSF) on Friday arrested six Pakistani nationals in an ongoing operation against the intrusion of Pakistani fishing boats in the Harami Nala creek area along the Indo-Pak maritime border in Gujarat. The Pakistani nationals were held after the Border Security Force (BSF) seized 11 fishing boats on Thursday. After the seizure of boats, the security agency has launched massive search operations. "The intrusion of Pakistani fishing boats and fishermen was detected yesterday in Harami Nala, Gujarat Frontier and BSF immediately launched a massive search operation in the area spread across 300 sq km. 11 Pakistani fishing boats have been seized so far," said BSF. Earlier, in a statement, the BSF said, "During routine patrolling, BSF personnel release a camera-mounted UAV in the sky to get a bird's eye view of the area."

36 bikes gutted in fire at parking lot in Ahmedabad

Ahmedabad : As many as 36 two-wheelers were gutted in a fire accident that took place at a parking spot of the Ahmedabad Municipal Corporation (AMC) in the Gota area of the city Friday noon. According to an official of the Fire Safety department of the AMC, a fire was reported at the open parking lot around 11:30 am. As many as three fire tenders were rushed to the spot as firefighters managed to douse the fire within half an hour. "A total of 36 bikes were gutted in the fire accident while we managed to save 600 other vehicles in the same parking lot. The cause of the fire remains unknown as we don't have an eye witness," said Inayat Shaikh, divisional officer, Fire Safety Department, AMC.

# Taking an aerial view of the city: Helicopter joyrides of Ahmedabad



Ahmedabad : On a Friday afternoon at the Sabarmati Riverfront in Ahmedabad, Indian Air Force (IAF) veteran and decorated pilot, Captain Nitin Welde, steps out onto a waiting arena for passengers to share a brief on the route operated by AeroTrans Services Pvt. Ltd., a provider of air charter services, from the Sabarmati Water Aerodrome.

Dressed in a white shirt—sporting epaulettes with four stripes on his shoulders—and dark-coloured pants, Captain Welde explains to passengers that the usual flight route over Sabarmati Ashram, Patang Restaurant, the Sabarmati Jail and the Narendra Modi stadium will be skipped due to the ongoing

cricket matches between India and the West Indies.

“Due to the matches, there is a lot of drone activity near the stadium and the Air Traffic Controller (ATC) has stopped us from taking that route. Instead, we will fly north over the city towards Gujarat Science City. We will orbit and come back,” said Captain Welde, who has over 30 years of flying experience, including 25 years spent in the IAF from where he retired in 2016.

After exiting the passenger bay, the pilot headed out to the helipad where a brown US-manufactured Bell 407 helicopter awaited the arrival of passengers. The six-seater helicopter is part of a fleet of nine helicopters and aircraft

owned by AeroTrans, a 2.5-year-old aviation company acquired by Ahmedabad-based pharmaceutical firm Hester Biosciences.

The single-engine, single-pilot helicopter can accommodate five passengers for a single joyride that costs Rs 2,360 per person, including an 18 per cent GST. Armed with a Rolls Royce engine, the rotary-wing aircraft can fly at a speed of 250 kilometres per hour. For the joyride, the helicopter maintains an altitude of 500 feet and clocks a speed of 180-210 kilometres to help passengers gauge the city better. “It can attain an altitude of 2000-2500 feet above the ground and has an air-conditioned cabin with large glass windows, providing a spectacular airborne view of the city.

The single-engine, single-pilot helicopter can accommodate five passengers for a single joyride that costs Rs 2,360 per person, including an 18 per cent GST. Before every joyride, the helicopter undergoes a daily maintenance activity when the in-house technical and

Addressing the businessmen and traders of Ahmedabad, the minister narrated the events of a meeting where he was present with PM Modi during the Covid lockdown where 25 different laws were changed within 24 hours to aid Covid vaccine research in India. “Modiji called a meeting during the lockdown in April 2020. In this meeting, there were scientists and owners of pharmaceutical companies. He asked them for a solution for Covid-19. Scientists told him that we should research on vaccines,” said the minister adding that local research was needed as bringing a vaccine from outside India would have taken a minimum of 10 years.

In the early hours of Thursday, officials from Crime Branch unit 3 of Mira Bhayandar Vasai Virar (MBVV) police arrested two men while they were transporting 50.20 kilograms of Ganja, a commercial quantity, on the Mumbai-Ahmedabad highway.

Acting on a tip off about the drugs smuggling, the team laid a trap around 12.45 am near Chinchoti over-bridge in Vasai (east). The duo was smuggling the contraband in a rickshaw which was moving towards Mumbai.

Their rickshaw was stopped and two men were found which contained the drugs worth Rs 11.44 lakh,” said unit head, Inspector Pramod Badakh.

The accused were identified as Ajay Waghe, 27, a resident of Jalasopara (east), and Jay Patil, 24, a resident of Dahisar (east).

“We are questioning them to find the source of the drugs and where they were taking it,” said a crime branch official.

An FIR has been registered against them under sections 8C, 22C, 25 and 29 of the Narcotics Drugs and Psychotropic Substances Act, 1985. As the Ganja is within commercial quantity, the accused face a jail term of minimum 10 years which may extend to twenty years, as per the Act.
