नों की थोक बिक्री अमेरिकी डालर को बैठक करेगी रीसद की गिरावट रुपया 16 पै

मुंबई, 12 नवंबर (भाषा)।

अक्टूबर, 2020 में यह संख्या 13,82,749 थी।

सियाम ने बताया कि पिछले महीने स्कूटर की बिक्री भी 21 फीसद घटकर 4,67,161 इकाई रही, जो एक साल पहले के इसी महीने में 5,90,507 इकाई की थी। उद्योग निकाय के अनुसार पिछले महीने यात्री वाहनों, तिपहिया, दोपहिया और क्वाड्रिसाइकिल वाहनों का कुल उत्पादन 22,14,745 इकाई का रहा, जो पिछले वर्ष अक्टूबर में हुए 28,30,844 इकाई के उत्पादन से 22 फीसद कम है। सियाम के महानिदेशक राजेश मेनन ने कहा, 'वाहन निर्माता चालू वित्त वर्ष के शुरुआत में हुई कम बिक्री से उबरने के लिए ल्योहारी सीजन के दौरान मजबूत बिक्री की उम्मीद लगा रहे थे। सेमीकंडक्टर की कमी और कच्चे माल की कीमतों में वृद्धि से हालांकि उद्योग की उम्मीदों को बड़ा झटका लगा है।'

घरेलू शेयर बाजारों में वृद्धि के बीच रुपया शुक्रवार को शुरुआती कारोबार में अमेरिकी डालर के मुकाबले 16 पैसे मजबूत हो कर 74.36 पर पहुंच गया। अंतर बैंक विदेशी मुद्रा विनिमय में रुपया डालर के मुकाबले मजबूत रुख के साथ 74.36 पर खुला। इसमें पिछले बंद के गई। बृहस्पतिवार को रुपया अमेरिकी डालर की स्थिति को दर्शाने वाला डॉलर 95.23 पर आ गया। रिलायंस सिक्वोरिटी मुद्राओं में सुधार को देखते हुए भारतीय रुपया भी सुधार के साथ खुला। इसके अलावा वैश्विक मुद्राओं का संक्षिप्त विवरण

निवेश के लिए आकर्षक स्थान बनता जा रहा है... निजी क्षेत्र से सकारात्मक प्रतिक्रिया आ रही है। साथ ही भू-राजनीतिक घटनाक्रम भी भारत के पक्ष में हैं।' आर्थिक मामलों के विभाग के सचिव अजय सेठ ने शुक्रवार को बताया कि बैठक के दौरान निजी निवेश आकर्षित करने के लिए भूमि, जल से जुड़े नियमों को सुगम बनाने पर विचार किया जाएगा। उन्होंने कहा कि इस बैठक का मकसद यह सुनिश्चित करना है कि केवल केंद्र सरकार द्वारा ही नहीं, बल्कि राज्य सरकारों द्वारा भी इस समय का उपयोग कर विकास को आगे बढ़ाया जाए।
