**Sub: Submission of Public Announcement and other documents for Buyback of Equity Shares of Gandhi Special Tubes Limited**

The Public Announcement will be published in the newspapers on Thursday, August 12, 2021, in terms of Regulation 7(i) of the Buyback Regulations.


