Following two recent cases, he said it appears that the Government of Brazil had sent a message to Indian Ministry of External Affairs (MEA) that they are carrying out some investigation against a former Governor and they suspect that at least 67 parties in India could be involved in supporting that Governor in money laundering.

Accordingly, he said, the MEA had directed ED to freeze bank accounts of 67 parties and most of them are "established exporters". He added that the MEA neither asked any clarification or details of the case nor did they seek any communication from the concerned parties.

Investor focus will also remain on global market trends and COVID-19 updates like the number of infection cases and news related to the progress of vaccines.
