# पिता-भाई की हत्या में वांटेड नाबालिंग पकड में आई

# हरिद्वार पुलिस ने अभिरक्षा में लिया, बॉयफ्रेंड मुकुल भाग निकला

जबलपुर ,(एजेंसी)। जबलपुर में 15 मार्च को रेल कर्मचारी पिता राजकुमार विश्वकर्मा और भाई तनिष्क की हत्या करने वाली नाबालिंग पुलिस गिरफ्त में आ गई है। करीब ढाई महीने की तलाश के बाद उसे मंगलवार की शाम हरिद्वार पुलिस ने अभिरक्षा में लिया। हालांकि, उसका बॉयफ्रेंड मुकुल सिंह अभी भी फरार है।

जबलपुर एसपी आदित्य प्रताप सिंह ने बताया कि मंगलवार को हरिद्वार पुलिस का फोन आया था। वीडियो कॉल पर नाबालिंग की तस्वीर दिखाई गई। जबलपुर पुलिस की एक टीम हरिद्वार के लिए रवाना की गई है। जल्द ही पुलिस उसे लेकर जबलपुर आएगी। उन्होंने कहा, 'अब वो दिन दूर नहीं, जब मुकुल सिंह भी पुलिस गिरफ्त में होगा। हरिद्वार पुलिस ने इलाके में नाकाबंदी कर दी है। उम्मीद है कि जल्द ही उसे भी गिरफ्तार कर लिया जाएगा।' आश्रम में छिपे थे, चौकीदार ने पुलिस
