In terms of Regulation 29 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that a meeting of the Board of Directors of REC Limited will be held on Thursday, August 4, 2022 *inter-alia* to consider and approve unaudited financial results (standalone & consolidated) of the Company for quarter ended June 30, 2022.

In this regard, it is informed that as per Company's code of conduct for regulating, monitoring and reporting of trading by designated persons and their immediate relatives, the Company vide letter dated June 17, 2022 had intimated that the closure of trading window shall commence from June 20, 2022, on account of consideration of a proposal for issue of bonus shares, and will remain closed till expiry of 48 hours after the declaration of the financial results for the quarter ended June 30, 2022 for trading in REC equity shares and listed debt securities (tax free bonds etc.) for all designated persons and their immediate relatives.

In view of the above, the period of closure of trading window for trading in REC equity shares and listed debt securities (tax free bonds etc.) is from June 20, 2022 to August 6, 2022 and trading window will open with effect from August 7, 2022. During the above mentioned closure period, all designated persons and their immediate relatives have been advised not to deal in REC's equity shares / securities.
