## SUMMARY OF PROCEEDINGS OF THE EXTRA ORDINARY GENERAL MEETING

The Extra Ordinary General Meeting of Jay Shree Tea & Industries Limited ('the Company') was held on 15<sup>th</sup> March, 2022 at 3:30 P.M. through two way Video-Conferencing ("VC") or Other Audio Visual Means ("OAVM").

Mr.S.K.Tapuriah, an Independent Director of the Company chaired the Meeting. He welcomed all the Members, Directors and other participants to the Meeting. The requisite quorum being present, Meeting was called to order.

The Chairman informed that the Company, while convening and conducting the Meeting, the Company adhered to the applicable circular(s) issued by the Ministry of Corporate Affairs and the Securities and Exchange Board of India and other social distancing norms in view of outbreak of Covid-19 pandemic.

The Chairman then delivered his address to the Members regarding the agenda of the meeting and with the consent of the Members' present, the notice was taken as read.

Mr.R.K.Ganeriwala, President & Secretary of the Company informed the Members that the Company had provided remote e-voting facility as well as e-voting at the AGM to all persons who were members of the Company as on 8<sup>th</sup> March, 2022 being the cut-off date through Central Depository Services Limited (CDSL). The Remote e-voting was open from Friday, the 11<sup>th</sup> March, 2022 (9:00 A.M.) to Monday, the 14<sup>th</sup> March, 2022 (5:00 P.M.) and electronic voting during the EGM. The Company had appointed Mr.M.R.Goenka, Practicing Company Secretary of M/s. MR & Associates., Company Secretaries (FCS-4515/CP-2551), of M/s. MR & Associates., Company Secretaries, Kolkata, as the Scrutinizer for the purpose of scrutinizing the remote e-voting and e-voting during the Meeting in a fair and transparent manner.

After the resolution being duly tabled at the Meeting, the Chairman then invited questions and comments from the Members who had registered themselves as Speakers and were attending the Meeting through VC / OAVM and the same were satisfactorily responded and clarified by the President & Secretary of the Company.

Members were requested to cast their votes through the e-voting platform provided by CDSL. Mr.R.K.Ganeriwala informed the Members that the consolidated results of e-voting would be declared within two working days from the date of the EGM and the same shall also be intimated to the Stock Exchanges and posted on the website of the Company and that of the Stock Exchanges and CDSL.

The Chairman then thanked the Members present and declared the meeting as closed. The meeting & Inconcluded at 3:50 p.m. (including the time allowed for e-voting at EGM).
