## Summary of proceedings of the 10th Annual General Meeting:

The 10<sup>th</sup> Annual General Meeting of the members of the Infibeam Avenues Limited was held on Wednesday, September 30, 2020 through Video Conferencing (VC) / Other Audio Video Means (OAVM) facility. Mr. Ajit C. Mehta, Chairman of the Company, Chaired the meeting. The requisite quorum was present. Mr. Shyamal Trivedi, Vice President & Company Secretary welcomed all the members and dignitaries of the Company present in the meeting. He further informed that in view of the restrictions due to outbreak of COVID-19 and considering the social distancing norms, the AGM was conducted through VC / OAVM and the meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI). He further informed the members that the Members who are attending the meeting through Video Conferencing will be counted as present for the purpose of Quorum. He then introduced all the Board Members, KMPs and Auditors present in the meeting.

Mr. Ajit C. Mehta, Chairman of the Company addressed the Members present.

Then, Mr. Shyamal Trivedi, Vice President & Company Secretary informed to the Members that as per the provisions of the Companies Act, 2013 and SEBI Listing Regulations, the company provided the remote e-voting facility to all the persons who were members as on the cut-off date i.e. September 23, 2020 for vote on resolutions set out in the notice of AGM. The remote e-voting was kept open from September 26, 2020, Saturday (from 9.00 am) to Tuesday, September 29, 2020 (till 5.00 p.m.). Members attending the AGM who had not cast their vote by remote e-voting were entitled to exercise their right to vote by e-voting during the AGM. Necessary registers, certificates and reports were kept open for inspection during the AGM in electronic mode.

Mr. Shyamal Trivedi, Vice President & Company Secretary also informed the members that Mr. Ashish Doshi, Partner, M/s. SPANJ & Associates, Company Secretaries has been appointed as the scrutinizer for the purpose of scrutinizing the e-voting process and the E- voting results along with the Scrutinizers' Report will be placed on the Company's website, Link In Time website and the results will also be communicated to the Stock Exchanges.

Thereafter, Mr. Shyamal Trivedi, Vice President & Company Secretary requested Mr. Vishal Mehta, Managing Director to address the members.

After Managing Director's address, Mr. Shyamal Trivedi informed that the notice of the 10<sup>th</sup> Annual General Meeting along with the Annual Report, have been sent by electronic mode to those Members whose e-mail addresses were registered with the Company or RTA or Depositories.
