PROCEEDINGS OF THE 25TH ANNUAL GENERAL MEETING OF THE SHAREHOLDERS OF DECILLION FINANCE LIMITED HELD ON MONDAY, 30TH DAY OF SEPTEMBER, 2019 AT 2.00 P.M. AT OSWAL CHAMBERS, EITMA, 5TH FLOOR, 2, CHURCH LANE, KOLKATA - 700 001

The 25th Annual General Meeting (AGM) of the Company was held on Monday, the 30th September, 2019 at 2.00 p.m. at "Oswal Chambers", 5th Floor, EITMA, 2, Church Lane, Kolkata-700001.

Mr Jitendra Kumar Goyal, Managing Director of the Company occupied the Chair. 87 members were present in person/proxy and as authorized representative as per the attendance register maintained by the Company.

The Chairman called the meeting in order as the requisite quorum was present throughout the meeting. He introduced the Directors present on the dias to the members.

The Chairman delivered his speech on the agenda items mentioned in the AGM notice. The Chairman further informed the Shareholders that pursuant to Section 108 of the Companies Act, 2013 read with rules made thereunder and the Listing Regulations, the Company had extended the remote e-voting platform of National Securities Depository Limited (NSDL) to all the members as on cut-off date, 23rd September, 2019 for exercising their voting rights in electronic form. The e-voting period was open from 9:00 a.m. on Friday, 27th September, 2019 and ended on Sunday, 29th September, 2019 at 5:00 p.m.

For the members who had not availed e-voting facility, the Chairman invited them to participate in the poll process to be conducted at the AGM. He further informed that pursuant to provisions of Section 108 and 109 of the Companies Act, 2013, Mr. Rajesh Ghorawat, Practising Company Secretary (Membership No: 7226; CP No. 20897) was appointed as the Scrutinizer to conduct the poll process and the e-voting process in a fair and transparent manner and to scrutinize the e-votes and poll papers and submit his report.

Thereafter, the agenda item nos. 1 to 3 as set out in the notice convening the AGM was concerned:

ORDINARY BUSINESS:

- To receive, consider and adopt the Audited Financial Statements (including Audited Consolidated Financial Statement) of the Company for the year ended 31st March, 2019 along with Directors' and Auditor's report thereon. (Ordinary Resolution)
- To appoint a Director in place of Mr. Jitendra Kumar Goyal, Managing Director (DIN: 00468744), who retires by rotation and being eligible, offers himself for re-appointment. (Ordinary Resolution)
- 3. To modify the terms and conditions of Statutory Auditors of the Company and fix their remuneration. (Ordinary Resolution)
