**Update on Arbitration Award**

The Hon'ble Arbitral Tribunal comprising of Hon'ble Justice A K Sikri, Former Judge Supreme Court of India, Presiding Arbitrator, Hon'ble Justice Reva Khetrpal, Former Judge High Court of Delhi, Co-arbitrator and Hon'ble Justice Alok Kumar Singh, Former judge Allahabad High Court, Co arbitrator had unanimously passed award dated 03.04.2023 for net sum of Rs 26.73 crores plus further interest of 10% p.a. from date of award till the date of payment in favour of MBL Infrastructure Ltd against NHAI for the completed project of construction of residential accommodation for NHAI staff at Pocket B-5, Sector 17, Dwarka, New Delhi.

The Hon'ble High Court of Delhi in the Execution Petition filed by the Company has directed NHAI to deposit the entire arbitration award with upto date interest with the Registrar General of High Court of Delhi. The Company had filed Execution Petition for Rs 27,80,08,705/-including interest upto 31.07.2023 and future interest @10% p.a.

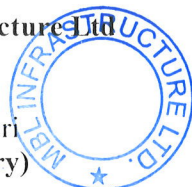
