Sub: Corrigendum to the Audited Consolidated and Standalone Financial Results for the year ended March 31, 2020,

With reference to the Audited Consolidated and Standalone Financial Results of the Company for the year ended March 31, 2020, as approved by the Board of Directors on May 25, 2020 and filed with the Stock Exchanges on May 25, 2020, we wish to inform you of an inadvertent clerical error related to a disclosure in Previous year figures:

- (A) In Consolidated Balance Sheet in lines 'Other Financial Liabilities' and 'Other Current Liabilities' which have been disclosed as Rs. 1807.38 lakhs and Rs. 1238.33 lakhs respectively instead of Rs. 1985.54 lakhs and Rs. 1060.17 lakhs
- (B) In Standalone Balance Sheet in lines 'Other Financial Liabilities' and 'Other Current Liabilities' disclosed as Rs. 1083.07 lakhs and Rs. 448.41 lakhs respectively instead of Rs. 1261.23 lakhs and Rs. 270.25 lakhs.
