एक बदमाश को दबोचने का प्रयास भी

किया गया लेकिन उसने तमंचे की बट मारकर घायल कर दिया। गोलीबारी करने के बाद हमलावर बाइक से भाग निकले। गोलियों की आवाज सुनते ही दुकानों के शटर गिर गए। बाजार में सन्नाटा पसर गया और लोग घरों में कैद हो गए। फायरिंग की सूचना पुलिस को दी गई। फिलहाल, पुलिस ने इस घटना के संबंध में एक युवक को हिरासत में लिया है। एसएसपी ने हमलावरी की गिरफ्तारी के लिए पांच टीमें गठित कर दी हैं।
