ZAGREB: Croatian conservative leader Andrej Plenkovic was formally appointed prime minister-designate on Friday for a third consecutive term after he forged an alliance with an extreme right party following an inconclusive election. Plenkovic's ruling Croatian Democratic Union won the most votes at last month's parliamentary vote in the European Union nation, but not enough to stay in power on their own. The party this week agreed to form a coalition with far-right Homeland Movement for a parliamentary majority.



# Netanyahu vows to defeat Hamas amid US pressure

Benjamin Netanyahu has vowed Israel can "stand alone", after the US warned arms shipments could be stopped if he orders a full-scale invasion of Rafah in Gaza.

Thousands of people have already fled the southern city after the Israeli military began what it called a "limited" operation on Monday, the BBC reported. US President Joe Biden has repeatedly warned against the operation, saying that it would cross a "red line". But Netanyahu dismissed the US warning, saying Israel would fight on.

"If we need to ... we will stand alone. I have said that if necessary we will fight with our fingernails," the prime minister said. Netanyahu also invoked the war of 1948 - where the newly formed State of Israel was attacked by a coalition of Arab states - to dismiss the US warnings.

"In the War of Independence 76 years ago, we were the few against the many," he said "We did not have weapons. There was an arms embargo on Israel, but with great strength of spirit, heroism and unity among us - we



were victorious." Despite Netanyahu's comments, his government has come under pressure after the US suspended the delivery of 1,800 2,000lb (907kg) bombs and 1,700 500lb bombs over fears that they could cause civilian deaths in Rafah. Biden went further still in an interview with CNN on Wednesday, saying that if the attack went ahead he would further suspend supplies of artillery shells and other weapons.

Yoav Gallant, Netanyahu's defence minister, dismissed the US warnings, saying Israel's "enemies as well as ... best of friends" should understand that his country "cannot be subdued". "We will stand strong, we will achieve our goals," he added.

The comments came hours after the UN said more than 80,000 people had fled Rafah since Monday amid constant bombardment and as Israeli tanks massed close to built-up areas. The UN also warned that food and fuel were running out for the more than one million still sheltering in the city, because it was not receiving aid through nearby crossings.

Israeli troops took control and closed the Rafah crossing with Egypt while the UN said it was too dangerous for its staff and lorries to reach the reopened Kerem Shalom crossing with Israel. Israeli forces were conducting "targeted raids" against Hamas elements in the city.

## Israel ramps up attacks in Rafah

The Israeli military has ramped up its attacks in Rafah, southern Gaza, and hit Gaza City while crippling humanitarian aid operations across the Palestinian territory as ceasefire talks ended without a deal, as per a report by Al Jazeera.

"People are petrified. People have been fearing this for a long, long time and it is now upon us. There is constant bombardment. There is smoke on the horizon. There are people on the move," Sam Rose, director of planning for the UNRWA. He said Israel was subjecting Gaza to a "medieval siege" in a "scorched earth" war.

Israeli forces seized control of the Rafah border crossing, sealing the crucial entry point for humanitarian aid. "No aid has come into Gaza now since Sunday. No aid, no fuel, no supplies, nothing."

Daniels' story of a sexual encounter with Trump was a crucial building block for prosecutors, who are seeking to show that the Republican and his allies buried unflattering stories in the waning weeks of the 2016

presidential election in an effort to illegally influence the race.

Trump, who denies the sexual encounter ever happened, walked out of the court in a rage Thursday, angrily telling reporters, "I'm innocent." His attorneys pushed for a mistrial over the level of tawdry details Daniels went into on the witness stand, but Judge Juan M.

Merchan denied the request. Over more than 7 1/2 hours of testimony, Daniels relayed in graphic detail what she says happened after the two met at a celebrity golf outing at Lake Tahoe where sponsors included the adult film studio where she worked. Daniels explained how she felt surprise, fear and discomfort, even as she consented to sex with Trump.

# Russia attempts to breach Kharkiv region in Ukraine

Ukraine rushed reinforcements to its northeastern Kharkiv region to hold off a Russian attempt to breach local defences, authorities said, a tactical switch by Moscow that Ukrainian officials have been expecting for weeks as the war stretches into its third year, the AP reported.

Intense nighttime shelling targeted Vovchansk, in the Kharkiv region and less than 5 kilometres from the Russian border, regional Gov. Oleh Snyehubov said. The barrage prompted authorities to begin the evacuation of around 3,000 people.

Then, around dawn, Russian infantry tried to penetrate the Ukrainian defences near Vovchansk, Ukraine's Defence Ministry said, adding that it had deployed reserve units to fend off the attack.

Russian military bloggers said the assault could mark the start of a Russian attempt to carve out a "buffer zone" that President Vladimir Putin vowed to create earlier this year to halt frequent Ukrainian attacks on Belgorod and other Russian border regions.

Ukraine had previously said it was aware that Russia was assembling thousands of troops along the northeastern border, close to the Kharkiv and Sumy regions. While the Kremlin's forces launched their most recent ground offensive in eastern Ukraine, Ukrainian

intelligence officials said they expected the Kremlin's forces to attack in the northeast, too. Ukrainian President

Volodymyr Zelenskyy said his country's military had anticipated the attack and had calibrated its response.
