This has reference to our earlier request dated 22.06.2020 for extension of timeline for submission of audited financial results for the quarter and year ended on 31<sup>st</sup> March, 2020.

In view of the prevailing Covid-19 pandemic situation in the Country, the SEBI vide its circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/38 dated 19.03.2020 had extended the timeline for submission of annual audited financial results from 30<sup>th</sup> May, 2020 to 30<sup>th</sup> June, 2020. However, in view of continuation of the situation, the SEBI vide its circular No. SEBI/HO/CFD/CMD1/CIR/P/2020/106 dated 24.06.2020 further extended this timeline till 31.07.2020.

We would like to inform that the statutory audit of the Company was in advance stage of completion and we were hopeful that the audit will be completed by 25<sup>th</sup> July, 2020 and we will be able to publish the Financial Results both stand alone and consolidated, for the quarter and year ended 31<sup>st</sup> March, 2020 within the extended timeline limit. However, some of the team members of the audit team were struck with Covid-19 and the audit activities were held up. Meanwhile Mr. M. K. Madan, Proprietor, M/S Madan & Associates, Chartered Accounts, New Delhi, Statutory Auditors of the Company, also got infected with Covid-19 and was hospitalized on 7<sup>th</sup> July, 2020 and all the audit activities were paralyzed and the audit could not be completed till date.

Though Mr. Madan has been discharged from the Hospital on 17<sup>th</sup>July 2020 but even at the time of discharge he was not tested negative for Covid-19 and has been advised strict home quarantine as per protocol. On the other hand, in view of prevailing Covid-19 situation in Delhi and non-availability of public transport, all the employees of Corporate Office at New Delhi are still working from home and have very limited access to the financial documents.
