In terms of IEOI, PRAs shall be permitted to submit resolution plan(s) for any/all such Clusters under Option II even if such Cluster has not been identified by the PRA in the EOI submitted by them, and shall further be permitted to submit resolution plan under Option I even if such PRA had originally submitted EOI only for one or more Cluster(s) in Option II, subject to terms of IEOI and Request for Resolution Plans to be issued by Resolution Professional (“RFRP”).

**Note:**

Certain issues pertaining to the expressions of interest received from the prospective resolution applicants have been noticed and the same will be duly communicated to the prospective resolution applicants by the Resolution Professional and/or his authorised representatives.

The inclusion of the aforementioned entities in the final list of PRAs prepared in terms of Regulation 36A(12) of the CIRP Regulations shall be dependent on such entities addressing and rectifying the concerns (if any) raised / as maybe raised by the Resolution Professional and/or his authorised representatives.

In terms of Regulation 36A(11) of the CIRP Regulations, any objection to inclusion or exclusion of a PRA in the provisional list maybe made with supporting documents within five days from the date of issue of the provisional list, i.e. on or before 13<sup>th</sup> April 2023. If any objections are received, then the undersigned shall, in good faith, consider the objections and shall endeavor to issue final list of PRAs, in terms of Regulation 36A(12) of the CIRP Regulations.

Rights and remedies of the Resolution Professional and the committee of creditors under applicable laws and the terms of the RFRP to be issued are hereby expressly reserved.
