Sub.: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - update on the material impact of CoVID-2019 pandemic on the company and its business operations.

Pursuant to the provisions of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we would like to inform you that due to outbreak of Pandemic 'Novel Coronavirus' (CoVID-2019), and consequent lockdown announced by the Central and State Governments, the Company had temporarily suspended operations at its manufacturing units situated at Paithan and Bhandara w.e.f. 23rd March, 2020 as a measure to ensure its employees' safety and containment of spread of CoVID – 2019. We have separately shared an intimation in this regard on 23rd March, 2020.

The Company has gradually resumed its operations in lines with the permission granted by the local administrations at Paithan Plant and Bhandara Plant on 16th April, 2020 and 11th May, 2020 respectively, after taking necessary precautionary measures. We have separately shared an intimation in this regard on 16th April, 2020 and 11th May, 2020. Presently, the operations at Paithan Plant and Bhandara Plant are running at about 60% and about 50% of their total capacity respectively.

The Company is mainly engaged in the auto ancillary business viz. in manufacturing & marketing of Friction Materials comprising of Brake Lining, Clutch Facing, Disc Brake Pad, Roll Lining, Brake Block etc. The company has also deployed its surplus funds into various asset classes.

There is a lot of uncertainty in the market especially in the Auto Sector. The Company is mainly a supplier of auto components and the demand for such products majorly depends on the overall performance of the Auto industry.

There has been production loss during the period of lockdown and presently also there is also low capacity utilization. However, this situation is gradually improving upon relaxations granted by the State governments.

Due to the outbreak of the pandemic and consequent suspension of operations there has been significant reduction in sales and revenues and which in turn would adversely impact profitability of the Company in 1st quarter ended 30th June, 2020. Since most of parts of the Country are still under lockdown, no major operations are being taken by industries elsewhere in the Country. This might lead to a supply chain bottle necks, availability of necessary manpower and disruption in transportation for a temporary period of time. In order to mitigate some of the impact, the Company has taken various initiatives to manage its costs across the organization.

Further, the Company has encouraged work from home for its employees at its offices, discouraging employees' travel, minimizing contact and maintain social distancing norms.

Current circumstances are extremely uncertain and business landscape is fast changing and continuously evolving. Hence, it is not possible to estimate the full impact of CoVID-2019 on Company's business at this point of time. However, the company will keep you updated on any further development in this regard and also disseminate the information on its website of the Company at www.hindcompo.com.
