We write in continuation to our earlier intimation dated August 14, 2023, relating to the petitions filed under Section 9 of Insolvency and Bankruptcy Code, 2016 ("**IBC**") with Hon'ble National Company Law Tribunal, Jaipur Bench ("**NCLT**") by some of operational creditors namely Dow Chemical Japan Limited (*formerly known as Performance Materials Japan Kabushiki Kaisha*), Allnex Resins (Shanghai) Company Limited and H.S.
