

Amendments to Memorandum of Association of the Company, in brief:

Regulation 30 of SEBI (LODR) Regulations, 2015 read with PART A of PARA A of Schedule III of SEBI (LODR) Regulations, 2015 and SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015:

The members of the Company at their Extra-Ordinary General Meeting held on Thursday, 21st March, 2024, approved Increase in Authorised Share Capital of the Company from Rs. 81,00,00,000/- (Rupees Eighty One Crore only) divided into 81000000 (Eight Crore Ten Lakh) Equity Shares of Rs. 10/- (Rupees Ten) each to Rs. 1,05,00,00,000/- (Rupees One Hundred Five Crore only) divided into 105000000 (Ten Crore Fifty Lakh) Equity Shares of Rs. 10/- (Rupees Ten) each by altering the Capital Clause (Clause V) of the Memorandum of Association of the Company as below:
