Pursuant to Regulation 30 of the SEBI (Listing Obligations And Disclosure Requirements) Regulations, 2015 and subject to the provisions of the SEBI (Share Based Employee Benefits) Regulations, 2014 (collectively referred to as 'SEBI Regulations') and in accordance with 'PVR Employee Stock Option Plan 2020' ("PVR ESOP 2020"/ "Plan"), the Nomination and Remuneration Committee ('Committee') on September 8<sup>th</sup>,2020, has approved the cancellation of 4,000 Option (Four Thousand options) granted to an employee of the company due to his ceasing in the employment of the Company.
