# FB blocks #ResignModi by 'mistake', restores it later

### Govt never issued any direction to remove this hashtag, says Meity

New Delhi, 29 April

 amid raging criticism of the government's handling of the Covid crisis, but restored it hours later calling it a mistake.

The blocking on Wednesday, Facebook said, wasn't at the behest of the government.

Facebook isn't the first social media company to censure posts critical of government handling of the Covid-19 crisis. Twitter had removed or restricted access to several critical posts on orders from the government, which called it fake news.

"We temporarily blocked this hashtag by mistake, not because the Indian government asked us to, and have since restored it," a Facebook spokesperson said in a statement on Thursday. It however did not elaborate.

In a tweet, the Ministry of Electronics and IT said: "Govt has not issued any direction to remove this hashtag. Facebook has also clarified that it was removed by mistake."


