NOTICE is hereby given pursuant to Section 108 of the Companies Act, 2013 ("Act") and other applicable provisions, if any, of the Act read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("Rules"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and the relaxations and clarifications issued by Ministry of Corporate Affairs ("MCA") vide General Circular No. 14/2020 dated April 08, 2020 and General Circular No. 17/2020 dated April 13, 2020 and General Circular No. 22/2020 dated June 15, 2020 ("Circulars"), that the Extra General Meeting of the Members Shangar Décor Limited will be held on Monday, September 28, 2020 at 03.30 PM IST through video conferencing ("VC"), to transact the following special businesses:

Special Resolutions to be passed through combination of remote e-voting/physical vote:

01. To Consider and approve sub division of Equity Shares:

In this regard, it is proposed to consider and if thought fit, to pass the following resolution as Special Resolution:

"RESOLVED THAT pursuant to the provisions of Section 61(1)(d) and all other applicable provisions of the Companies Act, 2013 ("the Act"), Companies (Share Capital and Debentures) Rules, 2014 ("the Rules"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 [including any statutory modification(s) or re-enactment(s) thereof, for the time being in force], subject to approval of the shareholders of the Company and subject to other applicable approval(s), sanction(s) of the statutory or regulatory authorities, as may be required in this regard, consent of the members of the Company be and is hereby accorded for sub-division of each existing equity share of face value of Rs. 10/- (Rupees ten only) each into two (2) equity shares of face value of Rs. 5/- (Rupee five only) each, which shall rank pari passu in all respects with the existing equity shares with effect from the record date."

"RESOLVED FURTHER THAT pursuant to the sub-division of equity shares of the Company with effect from the record date, each equity share of the Company of face value of Rs. 10/- (Rupees ten only) each in the issued, subscribed and paid-up equity share capital shall stand sub-divided into 2 (two) equity shares of face value of Rs. 5/- (Rupee five only) each."

"RESOLVED FURTHER THAT upon sub-division of the equity shares as aforesaid and with effect from the record date, the existing share certificate(s) in relation to the issued equity shares of the face value of Rs. 10/- (Rupees ten only) each, shall be deemed to have been automatically cancelled and shall be of no effect and that the Board may, without requiring surrender of the existing Share Certificate(s) by the members, issue new Share Certificate(s) of the Company, in lieu of the existing share certificate(s) and in case of the equity shares held in the dematerialized form, the number of sub-divided equity shares shall be credited proportionately into the respective beneficiary demat accounts of the members of the Company held with Depository Participants, in lieu of the existing credits present in respective beneficiary demat accounts."

"RESOLVED FURTHER THAT the Board of Directors of the Company [which expression shall include any Committee thereof or any other person(s) as may be authorized by the Board in that behalf], be and is hereby authorized to do all such acts, deeds, matters and things including to fix & announce record date, to make appropriate adjustments on account of sub-division of Equity Shares to the number, exercise price etc. of with effect from the record date, to delegate all or any of its powers herein conferred to the Company Secretary or any other officer(s) of the Company, to give such directions as they may in their absolute discretion deem necessary, proper or desirable, to apply for requisite approvals, sanctions of the statutory or regulatory authorities, as may be required, to sign, execute necessary applications, papers, documents, undertakings and other declarations for submission with stock exchanges, Registrar of Companies, Registrar & Share Transfer Agent, depositories and/or any other regulatory or statutory authorities, to appoint legal representatives, advocates, attorneys, to settle any question, difficulty that may arise with regard to the sub-division of the equity shares as aforesaid and to carry out/execute all matters in connection therewith and incidental thereto in order to give full effect to this resolution without any further approval of the shareholders."

02. To consider and approve alteration of Capital Clause of the Memorandum of Association of the Company:

In this regard, it is proposed to consider and if thought fit, to pass the following resolution as Special Resolution:

"RESOLVED THAT pursuant to the provisions of Sections 13, 61 and other applicable provisions, if any, of the Companies Act, 2013 and the rules made thereunder [including any statutory modification(s) or re-enactment(s) thereof, for the time being in force], subject to such approvals as may be necessary and subject to approval of sub-division of equity shares by the members, consent of the members of the Company be and is hereby accorded to alter and substitute the existing Clause V of the Memorandum of Association of the Company with the following new Clause V:

"V. The Authorised Share Capital of the Company is Rs. 7,00,00,000/- (Rupees seven crores only) divided into 1,40,00,000 equity shares of face value of Rs. 5/- each."

"RESOLVED FURTHER THAT the Board of Directors of the Company [which expression shall include any Committee thereof or any other person(s) as may be authorized by the Board in that behalf], be and is hereby authorized to undertake, execute all such acts, deeds, matters and things as they may deem necessary, proper and/ or expedient, to apply for requisite approval(s) of the statutory or regulatory authorities, as may be required, to carry out all requisite, incidental, consequential steps and to settle any question, difficulty or doubt that may arise in order to give full effect to this resolution."

03. To Approve issuance of Bonus Shares:

In this regard, it is proposed to consider and if thought fit, to pass the following resolution as Special Resolution:

"RESOLVED THAT pursuant to the provisions of Section 63 and other applicable provisions, if any, of the Companies Act, 2013 read with Rule 14 of the Companies (Share Capital and Debentures) Rules, 2014 (including any statutory modification or re-enactment thereof for the time being in force), provisions of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018, Foreign Exchange and Management Act, 1999, SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, other applicable provisions of regulations and guidelines issued by the Securities and Exchange Board of India (SEBI) and Reserve Bank of India (RBI) from time to time, and in accordance with the provisions contained in the Articles of Association of the Company and pursuant to the recommendation of the Board of Directors of the Company ('the Board', which term shall include any Committee authorised by the Board to exercise its powers including powers conferred on the Board by this resolution), and subject to such other approvals, consents, permissions as may be necessary, consent of the members be and is hereby granted to capitalize the sum of ₹ 3,06,01,000/- (Rupees three crores six lakhs one thousand only) out of the Retained Earnings and/or other permitted reserves/ surplus of the Company for the purpose of issuance of 61,20,200 fully paid up bonus equity shares of Rs. 5/-, the aggregate nominal value of which would be Rs. 3,06,01,000/-, to the shareholders of the Company, whose names appear in the Register of Members maintained by the Company/ List of Beneficial Owners of the Depositories as on the record date to be determined by the Board in proportion of 1:1 i.e 1 (one) equity share of nominal value ₹5/- (Rupees five only) each for every 1 (one) equity share of nominal value of ₹ 5/- (Rupees five only) each."

RESOLVED FURTHER THAT the Board of Directors be and is hereby further authorized to delegate all or any of the powers conferred by this resolution on it, to any committee or sub-committee of Directors or any other Director(s), Company Secretary or any other Officer(s) of the Company to give effect to the foregoing resolutions, with the power to such committee/ subcommittee of the Board to further delegate all or any of its powers/ duties to any of its members."

Pursuant to the Circular No. 14/2020 dated April 08, 2020, issued by the Ministry of Corporate Affairs, the facility to appoint proxy to attend and cast vote for the members is not available for this EGM. However, the Body Corporates are entitled to appoint authorised representatives to attend the EGM through VC/OAVM and participate thereat and cast their votes through e-voting.
2. In view of the massive outbreak of the COVID-19 pandemic, social distancing is to be a pre-requisite and pursuant to the Circular No. 14/2020 dated April 08, 2020, issued by the Ministry of Corporate Affairs, physical attendance of the Members to the EGM venue is not required. Explanatory Statement under section 102 of Companies Act 2013

Item No. 1 and 2 – Sub Division of Equity Shares and Alteration of Capital Clause of Memorandum of Association:

As the shareholders are aware that the Equity Shares of the Company are listed and traded on the BSE Limited. Owing to the Company's strong performance during the last couple of years, market price of its equity shares has increased significantly. In order to provide enhanced liquidity to the Company's equity shares in the Stock Market and to make it more affordable for small investors, it is proposed to sub-divide each equity share of face value of Rs. 10/- each into 2 equity shares of the face value of Rs. 5/- each pursuant to the provisions of Section 61(1)(d) of the Companies Act, 2013 ("the Act"), the rules made thereunder and other applicable provisions. The Record Date for the aforesaid sub-division of equity shares shall be fixed by the Board (including any Committee thereof) for the proposed sub-division. In the opinion of the Board, proposed sub-division of the equity shares is in the best interest of the Company and the investors and therefore the Board at its meeting held on August 22, 2020, approved the aforesaid sub-division subject to requisite approval of the shareholders. It is informed that there will not be any change in the amount of authorized, subscribed and paid-up share capital of the Company on account of sub-division of equity shares.

Presently, the Authorised Share Capital of the Company is ₹ 7,00,00,000/- (Rupees seven crores only) consisting of 70,00,000 (seventy lakh) equity shares of ₹ 10/- (Rupees ten only) each.

The proposed split of equity shares of the Company would require consequential alteration of the existing Clause V of the Memorandum of Association of the Company to make face value of each equity share of Rs. 5/- each. The alteration to Clause V of the Memorandum of Association of the Company for split of equity shares as aforesaid requires members' approval in terms of Sections 13 and 61 of the Companies Act, 2013. Accordingly, resolutions 1 and 2 of this Notice seek Members' approval for alteration in share capital clause and consequential amendments to Memorandum of Association of the Company. The Board recommends the resolutions 1 and 2 for approval of the Members.

None of the Directors, Key Managerial Personnel and their relatives are concerned or interested, financially or otherwise, in the resolutions No. 1 and 2 of this Notice except to the extent of shares held by them or any concern or company controlled by them in the Company.

Item No. 3: Issue of Bonus Shares:

The Board of Directors in their meeting held on August 22, 2020 and subject to the consent of the members of the Company approved split of equity shares of Rs. 10/- each in to 2 equity shares of Rs. 5/- each and also recommended issue of Bonus Equity Shares of ₹ 5/- (Rupees five only) each credited fully paid up to eligible members of the Company in the proportion of 1:1 i.e. 1 (one) new fully paid-up equity shares of ₹5/- (Rupees five only) each for every 1 (One) existing fully paid-up equity share of ₹ 5/- (Rupees five only) each by capitalising a sum of ₹ 3,06,01,000/- (Rupees three crores six lakhs one thousand only) out of the Retained Earnings and/or other permitted reserves/ surplus of the Company. The issue of Bonus Shares is authorised by the Articles of Association of the Company and shall be made in line with the provisions of Section 63 of the Companies Act, 2013 and other applicable regulations and subject to such approvals, if required from any statutory authorities.

Presently, the Authorised Share Capital of the Company is ₹ 7,00,00,000/- (Rupees seven crores only) consisting of 70,00,00 (seventy lakh) equity shares of ₹ 10/- (Rupees ten only) each. If Company receives approval from the shareholders in general meeting on proposed resolution number 1 and 2 for split of equity shares, the Authorised Share Capital of the Company would be ₹ 7,00,00,000/- (Rupees seven crores only) consisting of 1,40,00,00 (one crores fourty lakh) equity shares of ₹ 5/- (Rupees five only) each.

The issue of bonus equity shares by way of capitalization of reserves and surplus as aforesaid for the purpose of issue of fully paid up bonus equity shares requires members' approval in terms of Sections 13, 61 and 63 of the Companies Act, 2013.
