Explanatory Statement under section 102 of Companies Act 2013

Item No. 1 and 2 - Sub Division of Equity Shares and Alteration of Capital Clause of Memorandum of Association:

As the shareholders are aware that the Equity Shares of the Company are listed and traded on the BSE Limited. Owing to the Company's strong performance during the last couple of years, market price of its equity shares has increased significantly.
